2. Senior Planner - re Application for Site Plan Approval - 75 Queen Street.

Moved by Dougall, seconded by Crow:

THAT, further to the Site Plan Review Report dated October 26, 2018 from the Development Services and Engineering Department regarding the development located at 75 Queen Street, the Accessibility Advisory Committee provides the following comments:

- That there are barrier-free curbs adjacent to accessible parking spaces.
- That there are Tactile Attention Indicators from accessible parking spaces to the building entrance if crossing a parking lot aisle.
- That there is direct, safe access to the main entrance either from walkways or sidewalks.
- That the walkways have a cross fall no greater than 2% and barrier-free spaces
- That any slopes or ramps have no more than a 5% grade.
- That the area around the accessible parking spaces be flat and free from storm-water drains.
- That the snow storage be kept away from the area of the accessible parking spaces.
- That sidewalks/walkways be constructed of concrete as the preferred first choice; and where pavers are used, the base beneath the pavers be constructed of concrete, have a flat surface, minimal beveled edges and minimal spacing between the pavers to lessen vibration.
- That the main entrance be equipped with power-operated doors.
- That pedestrian walkways through large parking areas are required and should be defined through the use of signage, special paving, lighting and/or landscaping elements.
- That the barrier free parking spaces be relocated to connect with sidewalks throughout the property.

3. Intermediate Planner - re Application for Site Plan Approval - New Commercial Parking Lot - 174 West Street South.

Moved by Dougall, seconded by Rizzo:

THAT, further to the Site Plan Review Report dated October 5, 2018 by the Intermediate Planner regarding the development located at 174 West Street South, the following comments be ratified as submitted to the Development Services and Engineering Department on October 30, 2018:

 That walkways be constructed of concrete as the preferred first choice; and where pavers are used, the base beneath the pavers be constructed of concrete, have a flat surface, minimal beveled edges and minimal spacing between the pavers to lessen vibration.

- That snow storage be situated a suitable distance away from the accessible parking spaces so that the snow and drainage will not affect these spaces.
- That the area around the accessible parking spaces be flat and free from storm-water drains.
- That there are direct and accessible connections from the internal sidewalks with the City's sidewalks.
- Pedestrian walkways through large parking areas are required and should be defined through the use of signage, special paving, lighting or landscaping elements.
