History

The history of Orillia is a legacy of the deeds and achievements of its residents. Every day we experience and build upon the history of accomplishments of the people we have known.

Since 1964, Orillia has inducted over 40 noteworthy residents from every field imaginable. While the choice as to who will be bestowed with the honor is difficult, the results are rewarding.

Criteria

- The inductee(s) must have received national and/or international recognition in his/her field of endeavor, including business and the arts. The recognition may have been by special award, prominent position, dissemination of works, philanthropy, etc.
- The inductee(s) should have lived in Orillia, or surrounding area, prior to the recognition.
- The inductee(s) shall have been influenced by the community in his/her success for a number of years prior to his/her recognition.
- The inductee(s) may have made a substantial impact on the destiny of Orillia and its citizens.
- The inductee(s) can be inducted into the Hall of Fame posthumously. In such instances, the family of the nominee must consent to the submission.

Submission Requirements

- Complete the attached nomination form.
- Attach a letters of support, explaining why your nominee is worthy of Hall of Fame consideration.
- Provide any additional material to support this nomination (publications, photos, etc.)

Award Presentation

Hall of Fame inductions are not an annual event and are based on quality of applications rather than quantity. When exemplary applications are received, the Committee will organize an induction Ceremony as time allows, and give notice as to when the ceremony will occur.
