

Official Rules for Be Kind Social Media Contest

CONTEST SPONSOR:

HOW TO ENTER:

NO PURCHASE NECESSARY. From October 22, 2021 at 9:00:00 AM ET through to December 19, 2021 at 11:59:59 PM ET, the City of Orillia will award one (1) one-month Family Fun Pass for the Orillia Recreation Centre.
