



Highlights from the Council Chamber

Council Meeting – Jan. 21, 2019

Below are highlights of what Council adopted at its meetings on Monday, Jan. 21, 2019.

The following includes changes or recorded votes to recommendations from the Jan. 21, 2019 Council Committee meeting. The wording below does not represent the exact wording of the motion and is meant as highlights of what was adopted.

Council Meeting:

- The report regarding Information Orillia regarding its 2018 Quarterly Report - Q4 was received as information. The quarterly payment instalment of \$10,000 was released to Information Orillia.
- The following new members were appointed for a four-year term to expire Nov. 14, 2022:

Chapter 251 of the City of Orillia Municipal Code – Delegated Authority was amended to designate the Chief Administrative Officer, or designate, with the authority to provide input to the Alcohol and Gaming Commission of Ontario on behalf of Council regarding an application for a cannabis retail store authorization. Chapter 251 of the City of Orillia Municipal Code – Delegated Authority was amended to establish the criteria set out in Schedule “B” of the report.

Chapter 954 of the City of Orillia Municipal Code - Smoking/Vaping/Waterpipe - Regulation - City Owned or Leased Property was adopted as set out in Schedule "D" of the report. Staff was authorized to hire a part-time Municipal By-law

Enforcement Officer, erect signage and implement a public education campaign in 2019, funded by the provincial funding provided by the Ministry of Finance associated with the legalization of cannabis.

- The Manager of Legislative Services will consult with municipal tenants regarding proposed revisions to Chapter 954 of the City of Orillia Municipal Code - Smoking/Vaping/Waterpipe - Regulation - City Owned or Leased Property.
- Council approved Zoning By-law Amendment Application No. D14-878 (2440536 Ontario Inc. - 600 Sundial Drive) in accordance with the Draft Zoning By-law Amendment as set out in the Supplementary Memo dated January 11, 2019 from the Development Services and Engineering Department.
- Council approved Official Plan Amendment Application D09-199, as amended, and Zoning By-law Amendment Application D14-877 (Waterfront Redevelopment Lands) in accordance with the Draft Official Plan Amendment and Draft Zoning By-law Amendment as set out in the Supplementary Memo dated January 15, 2019 from the Development Services and Engineering Department.
- Further to the request for a grant from the Simcoe County Elementary Athletic Council to use the West Orillia Sports Complex for wrestling tournaments on April 30 and May 3, 2019, the following sections of City Policy 4.2.1.1 - Guidelines - Grants Committee was waived:
 - Crown corporations and government agencies (e.g. school boards, social services, hospitals, business improvement associations, universities, etc.)
 - Sporting Groups

A grant was approved for the Simcoe County Elementary Athletic Council in the amount of \$1,240.94 pending ratification of the 2019 Budget.

- Further to the deputation by The Sharing Place Food Bank, the request for funding was referred to the 2019 Budget Committee.
- **A recorded vote was requested on the following by-law:**

A By-law to adopt Amendment Number 9 to the Official Plan for the City of Orillia (Waterfront Redevelopment Area).

This by-law amends the Official Plan for the City of Orillia to establish and set out a policy framework for the Waterfront Redevelopment Area as set out in Planning Report DSE-18-49 dated November 16, 2018 and Supplementary Memo No. 1 dated December 3, 2018 and Supplementary Memo No. 2 dated January 15, 2019 from the Development Services and Engineering Department.

- General insurance services was renewed through Jardine Lloyd Thompson Canada Inc. for the maximum period of time required to tender and award the general insurance services.
- \$300,000 was approved for the demolition of the southern portion of the 70 Front Street North plaza, allocated from the Land Acquisition Reserve.
- Pending capital budget approval for ongoing environmental monitoring of 70 Front Street North, staff was authorized to enter into a lease agreement with Elections Canada for two units within the 70 Front Street North plaza, not to exceed a lease term date of November 30, 2019
- Policy 1.2.1.6. - Pregnancy and Parental Leave for Mayor and Members of Council was adopted as set out in Schedule "A" of the report. Policy 1.2.1.7. - Council-Staff Relations was adopted as set out in Schedule "B" of the report.
