



# Highlights from the Council Chamber

## Council Committee Meeting – Nov. 1, 2021

Below is a snapshot of what Council Committee recommended at its meeting held on Monday, Nov. 1, 2021. Please note: The wording below does not represent the exact wording of the motion and is meant as highlights.

**Please note that Council Committee recommendations are subject to Council ratification and can be pulled for discussion and change in direction at the Council meeting being held on Monday, Nov. 8, 2021.**

- The acquisition of the sculpture named "The Steering Drive for the Mariposa Belle" by the artist Jimi McKee, as well as a request of \$3,000 for the sculpture's acquisition, was referred to the 2022 Budget deliberations.
- The Environmental Advisory Committee was authorized to proceed with a project to develop website content along with a tree planting and maintenance guide. The project was funded in an amount not to exceed \$8,000 from the existing Environment and Infrastructure Services Tree Canopy and Natural Vegetation Program operating budget.
- The report regarding the bi-annual update on the Municipal Accommodation Tax was received as information.
- **Postponed until Dec. 6, 2021.**  
The report regarding the feasibility of reducing the speed limit on all local roads, as defined in the City of Orillia Official Plan, to 40 kilometres per hour was received as information.
- Council waived Policy 2.6.1.1. - Guidelines and Procedures for Traffic Calming. Staff was directed to explore the feasibility of implementing all-way stops and other traffic calming measures at the corners of Matchedash Street South and Elgin Street, as well as Westmount Drive South and Rose Avenue, and Nottwasaga Street, Douglas Street and McKenzie Street.
- **Defeated:**  
Chapter 700 of the City of Orillia Municipal Code - Business Licensing was amended as set out in Schedule "A" of the report which will permit ice cream mobile catering trucks to operate on City streets provided a business licence is obtained and there is compliance with the restrictions set out in the schedule.
- The provision of school crossing guards will be eliminated by December 31, 2021 at the following locations:
  - Brant Street East at Laclie Street
  - West Street North at Orchard Park Public School

- Westmount Drive South at George Street/Argyle Avenue; Staff was directed to complete a fulsome review of all school crossing guard locations prior to the Fall 2023 school year.
- An interview panel was established for the purpose of interviewing and recommending the hiring of the Director of Business Development, Culture and Tourism to Council. The interview panel consist of the Chief Administrative Officer and the Director of Human Resources, as well as the following member(s) of Council:
  - Councillor Cipolla
  - Councillor Emond
  - Mayor Steve Clarke
- As recommended in confidential Report CS-21-35, the approximate legal costs in the amount of \$65,000 to fund the defense of the Notice of Application for Judicial Review was appropriated from the Tax Rate Stabilization Reserve. Staff was directed to pursue a joint retainer with Principles Integrity. Staff was directed to prepare communications outlining the City's position.
- The Municipal Class Environmental Assessment for Lacie Street will proceed based on reconstructing it to a two lane standard with bus laybys but without bike lanes between Neywash Street and North Street East and to a two or three lane standard with bike lanes but without bus laybys from North Street East to a point between North Street East and St. Jean Street as determined through the next phase of the Municipal Class Environmental Assessment process and to a three lane standard with bike lanes but without bus laybys between that point and Murray Street.
- The Mayor and Clerk were authorized to enter into a five-year agreement with the Ontario Society for the Prevention of Cruelty to Animals for shelter services at a cost of \$53,000 for the first year of the contract, with an increase annually over the term of the agreement on the anniversary of the contract by an amount equal to the Consumer Price Index for the previous 12-month period for Canada. Animal control services will be provided by the City of Orillia at a cost of \$94,573 for the first year, subject to Budget Committee approval.
- **Postponed until Dec. 6, 2021.**  
The Wastewater System Master Plan Update from Ainley & Associates Limited was received and adopted in principle.

The feasibility of implementing a pedestrian crossing treatment across Coldwater Road between Emily Street and Cameron Street to assist pedestrians accessing the path to Park Street.
