The Committee has Approved the following minor variance(s) from Zoning By-law 2014-44 for the conversion of an existing detached garage to a detached Additional Dwelling Unit with deficient setbacks to the principal Dwelling and side yard.

1	5.2.2.6 – The minimum distance between a principal Dwelling and an Additional Dwelling Unit contained within an Accessory Structure shall be 1.5m.	Minimum 1.5m	1.1m	0.9m
2	5.2.2.5 – The location of an Additional Dwelling Unit contained within an Accessory Structure shall be in accordance with Table 5.1 – Minimum Required Yards for Accessory Buildings or Structures	Minimum 1.2m	0.6m	0.6m
