PLEASE READ CAREFULLY BEFORE AGREEING TO THE FOLLOWING

The undersigned Participant acknowledges and agrees to the following terms:

I understand that the personal information provided by or on behalf of me through the Orillia 2024 Ontario 55+ Winter Games (“Games”) registration system has been collected by the Corporation of the City of Orillia (the “City”) and will be used and disclosed to third parties as required to facilitate my participation in the Games and associated events, programs, competitions, services (including food services and medical services), venues, lodging, travel and activities, as well as promotion of the Games and the City.

I hereby authorize the City (such authorization being an authorization and consent to disclosure of personal information within the meaning of the *Municipal Freedom of Information and Protection of Privacy Act*, RSO 1990, c M.56, as amended), including its Games Organizing Committee (the “GOC”), and the Multisport/Provincial Games Organization participating in my sporting event at the Games (the “PSO”) and/or each of their contractors and volunteers to collect, use and disclose, in their sole discretion, any and all personal information including, without limitation, (1) my name city/area of residence; (2) photographs of me; (3) video or other electronic images of me; and/or (4) quotations or summaries of written or oral opinions/statements about me or my participation in the Games (collectively, “Games Personal Information”) for publicity, advertising or other promotion of the Games or future Ontario Games or for the purpose of acknowledging or publicizing my achievements at the Games (collectively, the “Purposes”).

In the event that the City, including the GOC, requires technical assistance with the Games registration system from an official or contractor of the Ontario Ministry of Heritage, Sport, Tourism and Culture Industries (the “Ministry”), I acknowledge and authorize that such official or contractor may view any of my personal information collected through the registration system solely for the purpose of providing such technical assistance.

I further authorize the City (including the GOC) and the PSO to share my Games Personal Information with the Ministry for the Purposes. Such intended uses by the Ministry are necessary to the proper administration of the Ministry’s Games Ontario program, which is consistent with the Ministry’s mandate that is authorized under s. 4 of the *Ministry of Tourism and Recreation Act*, R.S.O. 1990, c. M.35, as amended.
